What is CiLCA?

CiLCA is a nationally recognised Level 3 qualification for officers working with parish, town, community or neighbourhood councils.

It provides the tools to:

- Make confident, informed decisions
- Advise on statutory duties and legal powers
- Ensure legal compliance
- Set a vision for your council's future
- Respond to challenges with clarity and professionalism.

It's not just a qualification, it's a confidence boost, a career milestone and an opportunity to make new friends and colleagues.

What You'll Learn

Through 5 structured units you will gain:

A working knowledge of council law, procedures and governance,

Confidence in community engagement and partnership working,

Practical experience applying knowledge to real council documents and

The ability to write clearly, concisely and professionally.

How the Training works

All sessions are delivered on-line. You will join a small cohort of fellow learners and will have opportunities to share ideas, ask questions and build supportive peer connections.

There is a total of seven sessions. An introduction, five unit-based sessions and a 'mop-up'.

Each session will last between 1.5 hours and 3.5 hours depending on the content of the session giving you a total of 15.5 hours formal training. In addition, your trainer will give you one-to-one feedback on your draft work providing a minimum of 20hours support in total.

Training is designed to help you stay motivated and on track with regular sessions and communication to help keep the momentum going.

How long will it take?

It is **estimated** that it will take 200 hours to complete the CiLCA portfolio and you **must** complete the portfolio within 12 months (more about this at the introductory session).
